



In science, the 4th graders have been studying how different animals live and work together. Since honeybees are one of the examples used in our textbooks, Mr. Morelock was invited to be a guest speaker for students in Mrs. Livingston's and Mrs. Hostetter's 4th grade classrooms. Did you know that Mr. Morelock is a bee keeper?

The students enjoyed a hands-on honey-bee presentation on September 9th by Mr. Morelock, and were extremely excited to see the "bee box" (with live honeybees inside) that Mr. Morelock had built! A student was chosen to be the "bee keeper" and had the opportunity to model the suit, gloves, and bee keeper's hat. Then, Mr. Morelock demonstrated how the honey is extracted from the combs. Two students had the opportunity to help spin the honey and then the group was shown how the honey is filtered through cheese-cloth.

Everyone really enjoyed the sweet honey Mr. Morelock brought back on Friday for us to sample! We even had homemade bread to eat it on thanks to a 4th grader's grandma! Thank you, Mr. Morelock, for providing a fun learning experience for all of us!





Middle School Language Arts

Middle school students are required to read and accumulate so many Accelerated Reader points each quarter. Sixth Graders need to earn 15 points. Seventh Graders earn 18 points and Eighth Graders 20 points. They are given time each day to read in class. However additional minutes at home are a must if students are going to accomplish their quarterly points. This is not a written assignment so students need reminders to read nightly. These AR points (Accelerated Reader) can make a difference. This is recorded in the grade book as a part of their quarterly grade.

Social Studies

The Government class has started learning the parts of the Constitution to get a better understanding of our federal government and how it operates. They, with the Street Law class, will be visited by Judge Jimmy Williams on October 16. He will be discussing the role of the judicial system and the courts system of Missouri. I am hoping the students get a little more understanding of what the courts system and the roles of lawyers and judges are.

The World History classes are learning about Ancient civilizations of Mesopotamia as well as ancient India and China. They will be completing a project that describes the ancient civilizations and their contributions to society. They are learning about the roles of men and women in these societies and how religion has shaped the culture of the civilizations.

The 8th grade American History class is on pace to learn about why exploration of the Americas' was so important to the wealth and standings of European nations. The students will be doing a project on the Explorers of the America's as well as learning about the different colonies that were established. The triangular trade and the exchange of ideas between the colonist and the Native Americans have interested the students as they examined the different tribes found in North America.

The 11th grade American History class is reviewing what they know about early American History and are currently learning about Westward Expansion. The students will be completing a project that has a time line that describes the culture and technological changes that occurred during the Industrial Revolution.

All classes are going well and I hope the students are exploring and learning not only ancient history but also current history as well. The students are challenged to discuss current issues such as the President's address to Congress, and the war in Afghanistan and Iraq. I hope this will allow the students to take an ownership in their learning and their own part in history.

From The Library 25A

How long may students have books? 21 school days

How much are library fines? 5 cents per school day

What is the largest fine that one book can accumulate? \$3.00 per book

How often do students have library? K-5 students have library once a week for one period. Jr. High-HS students can checkout before and after school.

<u>How many books can a students check out?</u> Lower elementary students may have two to three books on their record at one time. Older students, according to class needs.

<u>How can I keep my child from getting a fine?</u> Students may renew their books any time, even without the book at school.

What if my child loses a book? If a book is lost, you may pay for it at replacement cost. That transaction is recorded on your child's computer record. If you find the book later, the money is returned. We cannot allow you to replace books from Amazon, etc., due to the binding quality.

<u>What is Accelerated Reader?</u> AR is a computerized quiz program. Students read books, then take computer quizzes to test their knowledge of the books. Quarterly rewards are given. The goals per class are as follows:

2nd=6 pts; 3rd=8 pts; 4th=10 pts; 5th=12 pts; 6th=15 pts; 7th=18 pts; 8th=20 pts.

MIM Meeting August 31, 2009

Meeting Record:

The first benchmarking for Reading and Math will take place during the first part of school. We will use Aims web as our tool to help with benchmarking. Gail, Brandy and Janie will be doing the testing in the elementary. Gail will train Melanie to do the testing in Junior High. Other benchmarks for the year will be in December and the first part of May. Progress Monitoring for Reading will take place every 2 weeks and for Math it will take place once a month.

The MIM smart-goals and action plan were reviewed and discussed. We have attended a Positive Behavior Support Conference, the MIM Summer Institute and the PLC summer institute. We have also created a blanket agenda for use in our district. The agenda is to be used for every meeting and a copy of the agenda for each meeting must be put in Mrs. Ward's office.

The first District PLC meeting was held on a teacher workday before school started. The meeting consisted of getting everyone on board and of looking over our District's mission statement. The PLC Leadership team will meet the third Tuesday of every month at 7:30 a.m. Everyone is invited to attend. The team will also attend meetings at Kirksville once a month.

Staff development was discussed. The faculty needs to be trained on how to use the palms and how to implement the use of Aims web. Progress Monitoring for the MIM action plan was discussed. We will progress monitor in October, January, April and May. This will help us stay on target to meet the goals of our action plan.

The MIM time line was discussed. The time line included targets for 2008/2009, 2009/2010, 2010/2011, 2011/2012. We will continue to monitor the items on the time line and adjust according to what is found to be a need in our District.

The next meeting will be held on October 5th at 3:20 p.m. The leadership will discuss the progress monitoring of the MIM action plan and explore problem-solving processes for data conversations.



Department of Elementary & Secondary Education STANDARD COMPLAINT RESOLUTION PROCEDURE

This standard complaint resolution procedure applies to all programs administered by the Dept. of Elementary & Secondary Education (DESE) under the Goals 2000: Educate America Act and the Improving America's Schools Act (IASA).

What is a complaint for purposes of this policy? A complaint is an allegation that a specific federal or state law or regulation has been violated, misapplied, or misinterpreted by school district personnel or by the Department personnel.

A complaint under this procedure must be in writing and signed by the complainant. The written complaint must specify the details of the situation and must pertain to a law or regulation that is allegedly being violated, misapplied, or misinterpreted.

Who may file a complaint? Any parent or guardian, surrogate parent, teacher, administrator, school board, or other person directly involved with an activity, program, or project operated under the general supervision of the Department may file a complaint.

What types of complaints are recognized? There are two types of complaints:

- 1. A complaint alleging that a local school district is violating, misapplying, or misinterpreting a law or a regulation of the DESE; and,
- 2. A complaint alleging that the DESE is violating, misapplying, or misinterpreting a law or a regulation. How are complaints filed?
- 1. Complaints against local school districts: A complaint alleging that local school district officials have violated, misapplied, or misinterpreted a state or federal law or regulation must first be filed and resolution pursued in accordance with local district policy. If the issue cannot be resolved at the local level, the complainant may file a complaint with the Department. Before accepting such a complaint, the Department will ask for evidence of an attempt to resolve the issue at the local level. If the parties have not attempted in good faith to resolve the complaint at the local level, the Department may require the parties to do so and may provide technical assistance to facilitate such resolution. A question about local school district policies, rules, or practices which are not based on federal or state laws or regulations is not a complaint within the meaning of this policy and must be settled at the local school district level.
- 2. Complaints against the Department of Elementary and Secondary Education: A local school district official, a local board of education, or any person directly affected by actions of the Department may file a written complaint alleging that the Department or its personnel have violated, misapplied, or misinterpreted a state or federal law or regulation directly with the Department.

How does the Department hear and resolve complaints?

- 1. Any formal complaint against the Department or an unresolved complaint against a local school district related to the IASA is to be addressed to the Director of the Grants Management Section.
- 2. Within thirty days after receiving a complaint or appeal, the section director will resolve the complaint and inform interested parties in writing of this decision. In resolving the complaint, the section director may rely upon statements of the parties involved or may conduct an independent investigation. The section director may grant an extension of the thirty-day limit for just cause.
- 3. If a complainant disagrees with the decision of the section director, the complainant may within ten working days, appeal to the Deputy Commissioner of Education. This appeal must be in writing and state why the complainant disagrees with the decision.
- 4. Within thirty days after receiving an appeal, the Deputy Commissioner of Education will render a final administrative decision and notify the complainant in writing.
- 5. If the complainant disagrees with the decision of the Deputy Commissioner of Education in a matter relating to federal law or regulation, the complainant may request a review of the decision by the United States Secretary of Education in accordance with 34 CSR Part 76, section 76.781.

What other recourse is available in resolving complaints?

In some circumstances, complainants may have additional recourse in the courts or through the Administrative Hearing Commission.

Surrogate Parent can be Appointed for Some Students

Pursuant to the requirements of state law 162.997-999 RSMO, the State Board of Education is required to appoint a surrogate parent at such time as it becomes evident that a child with a disability does not have a parent or a person acting as a parent to participate in matters dealing with the provision of special education. For purposes of surrogate parent appointment, "parent" is defined as a biological parent, a guardian, or a person acting, as a parent of a child including,, but not limited to, a grandparent, a step parent, or a foster parent with whom the child lives. The term does not include the State if the child is a ward of the State. The term does not include a person whose parental rights have been terminated.

The local school district is given the responsibility to determine when a child with a disability who requires special education and who resides in the district is without a parent. The district must notify the Missouri Department of Elementary and Secondary Education the need to appoint a surrogate parent. Training for persons serving as surrogate parents will be provided by the Missouri Department of Elementary and Secondary Education and the district.

If you are interested in volunteering to serve as a surrogate parent, more information can be obtained from the district's surrogate parent contact person - Superintendent John Brinkley.

PUBLIC NOTICE

All responsible public agencies are required to locate, evaluate, and identify children with disabilities who are under the jurisdiction of the agency, regardless of the severity of the disability, including children attending private schools, highly mobile children, such as migrant and homeless children, and children who are suspected of having a disability and in need of special education even though they are advancing from grade to grade. The Linn County R-I School District assures that it will provide a free, appropriate public education (FAPE) to all eligible children with disabilities between the ages of 3 and 21 under its jurisdiction. Disabilities include autism, deaf/blindness, emotional disorders, hearing impairment and deafness, mental retardation, multiple disabilities, orthopedic impairment, other health impairments, specific learning disabilities, speech or language impairment, traumatic brain injury, visual impairment/blindness and young child with a developmental delay.

The Linn County R-I School District assures that it will provide information and referral services necessary to assist the State in the implementation of early intervention services for infants and toddlers eligible for the Missouri First Steps program.

The Linn County R-I School District assures that personally identifiable information collected, used, or maintained by the agency for the purposes of identification, evaluation, placement or provision of FAPE of children with disabilities may be inspected and/or reviewed by their parents/guardian believes the record is inaccurate, misleading, or violates the privacy or other rights of their child. Parents have the right to file complaints with the U.S. Department of Education or the Missouri Department of Elementary and Secondary Education concerning alleged failures by the district to meet the requirements of the Family Educational Rights and Privacy Act (FERPA).

The Linn County R-I School District has developed a Local Compliance Plan for the implementation of State Regulations for the Individuals with Disabilities Education Act (IDEA). This plan contains the agency's policies and procedures regarding storage, disclosure to third parties, retention and destruction of personally identifiable information and the agency's assurances that services are provided in compliance with the General Education Provision Act (GEPA). This plan may be reviewed in the Superintendent's office at the Linn County R-I School District during regular business hours.

Local school districts in the State of Missouri are required to conduct an annual census of all children with disabilities or suspected disabilities from birth to age twenty-one (21) that reside in the district. This census must be compiled by December 1 each year. This information is treated as confidential and must include: name of the child; parent/legal guardian's name/address; birth date and age of the child; the child's disability; and the services provided to the child. If you have a child with a disability or know of a child with a disability who is not attending the public school, please contact Superintendent John Brinkley or Special Education Director Nicole Head at the Linn County R-I School in Purdin, MO 64674.

This notice will be provided in native languages as appropriate.

PUBLIC NOTICE

Special education records which have been collected by the Linn County R-1 School District related to the identification, evaluation, educational placement, or the provision of special education in the district, must be maintained under state and federal laws for a period of three years after special education services have ended for the student. Special education services end when the student no longer is eligible for services, graduates, completes his/her educational program at age 22, or moves from the district.

This notification is to inform parents/guardians and former students of the Linn County R-1 School District's intent to destroy the special education records of students who received special education services during the prior to the 2005 school year. These records will be destroyed after December 1, 2008, in accordance with state law unless the parent/guardian or eligible (adult) student notifies the school district otherwise.

After three years, the records are no longer useful to the district, but may be useful to the parent/guardian or former student in applying for social security benefits, rehabilitation services, college entrance, etc. The parent/guardian or eligible (adult) student may request a copy of the records in writing or in person at the following address:


TEXT MESSAGING
