Dear Parents/Guardians,

Linn Co. R-1 School District is excited to see students return to the buildings on August 25th, 2020.

**Linn Co. R-1 will make every effort to minimize contact with COVID-19 and other communicable diseases; however, attending school will inherently introduce a greater risk of exposure.**

Linn Co. R-1 plans on moving forward with school on August 25th, 2020 unless the federal, state, county, or local health departments require us to close. Procedures may or can be modified at any time. It is impossible to plan for every scenario and situation. Linn Co. R-1 works with the Linn County Health Department and other state officials/departments.

Families in the district will have 2 options for school:

**OPTION 1:** Students return to Linn County R-1 campus and buildings for a traditional face to face school setting.

- Enhanced safety measures for all buildings will be put in place
- Students, staff, and school employees will be the only people allowed to enter Linn County R-1 buildings during the school day. Parents, community members and other visitors will not be allowed inside the buildings
- Social distancing will be in place when appropriate
- Masks will be optional for all staff and students, but recommended when social distancing is not possible
- Students will NOT be restricted to one area per day
- Students will have assigned seats in any area they are seated
- Students will NEED a water bottle. Water fountains will be turned off
- Hand sanitizer will be available
- Students will go to recess and have Art, Music and PE

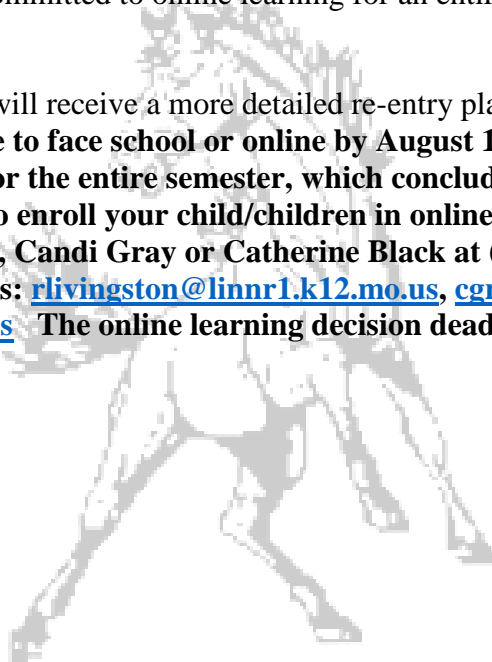

## **OPTION 2:** Students enroll in online classes.

- Students will be considered full time Linn County R-1 students and will follow a “school schedule” Tuesday-Friday
- Parents and students will receive technology support as needed. Additional instructional materials will be provided as needed to accommodate learning from home
- Students will not be permitted to participate in extra-curricular activities
- Students will be committed to online learning for an entire semester (August – December)

This is a basic plan. You will receive a more detailed re-entry plan soon. **We ask families to decide on face to face school or online by August 18, 2020. You will commit to the decision for the entire semester, which concludes on December 22, 2020.
